I further state that I hereby assume the risk for any, and all, injuries that I may sustain in connection with my participating in these competitions, and I hereby fully release and for ever discharge the organizers, city, country or state, where applicable, and their respective agents and employees from all claims, damages, actions, suits or judgments that may result from any types of injury I may sustain while participating in this event. I hereby indemnify and hold harmless the organizers, sponsors, and their respective agents, employees, successors and assigns from any injury or death so sustained.

I also assign the organizers or promoters of said event, sponsors of the event, city, country and state, where applicable, the exclusive commercial use of all photographers and photographic reproductions, televisions and motion pictures taken of me during the competition at this event.

I also agree to conduct myself in a professional sportsman-like manner prior to, during, and after the competition and while I am in the vicinity of the event. I have had an opportunity to be appraised of and reviewed all the rules and regulations applicable to the competition and understand that any violation of these rules, or any unsportsmanlike conduct, will be cause for immediate disqualification from this event in the sole discretion of the contest director.

Assumption of Risk

The undersigned further states that he/she merely assumes the risks for any injuries that he/she may sustain in connection with his/her participation in the event and he/she hereby fully releases and forever discharges the organizer, sponsors of events, city, country and state, where applicable, their respective directors, shareholders, agents, employees, successors and affiliated organizations from any claims, damages, actions, suits, or judgments resulting from their negligence or other causes that may result from any injury or death that the undersigned may sustain while participating in the event, and thereby indemnifies and holds harmless the organizers, where applicable, the Sponsors of the event, City, Country and State, where applicable, their respective directors, shareholders, agents, employees, successors, assigns, and affiliated organizations from any injury or death so sustained. The undersigned verifies his/her agreement to accept any and all risk or injury or death arising out of or related to the event by signing this release form.
